Product/Service Description	<p>Quantros has leveraged its expertise in data management and data analytics software to provide its own data products, including MEDMARX, the world's largest comparative database compiled from reported medication related errors and adverse drug reactions. MEDMARX was created by US Pharmacopeia, but was acquired by Quantros. Quantros has used its resources to build up and promote MEDMARX—a "prime the pump" strategy we have seen used by other data publishers. Subscribers have access to the complete MEDMARX hosted system that offers anonymous reporting of adverse drug events (ADEs) and information on actions taken and recommendations to avoid future ADEs.</p> <p>As a clearinghouse for reporting errors and ADEs, subscribers to MEDMARX benefit from access to the aggregated collection of data. MEDMARX includes tools for trends analysis and comparative reporting capabilities across the universe of contributed data or for slices of the data. Also, MEDMARX benefits from a facilitated data input capability available to Quantros clients who can submit data via the Safety and Risk Management (SRM) event manager and have it automatically pushed to MEDMARX.</p> <p>We often recognize data publishers that are moving up the value chain to provide high-value solutions to their audience. In this case, we are recognizing Quantros for expanding its own patient quality, safety and risk management solutions with a data product that provides added-value from aggregated content and data analysis tools.</p>
